### 1.0 - Introduction

Public Financial Management and Public Service Reforms are considered critical to effective and efficient service delivery across all three tiers of Government. One such reform area being pursued by the Bayelsa State Government along with the 8 Local Government Areas of the State is the adoption of the International Public Sector Accounting Standard (IPSAS) in budgeting and financial reporting.

Essentially, this includes the adoption of the New National Chart of Account (NCoA) and Budget Classification (BC) which helps in the improvement of the quality of public expenditure and financial management systems and ensures transparency and accountability in the use of public resources. Budget Classification (BC) and New Chart of Accounts (NCoA) is a complete listing of budgeting and accounting *items* where each item is *uniquely* represented by a *code* and grouped into tables of *related* data to track, manage and report, and accounting of public expenditure in an orderly, efficient and transparent manner. It is primarily for the implementation of a uniform accounting system that is IPSAS-compliant.

The migration to the IPSAS standard was sequel to the Federal Executive Council (FEC) approval of July 2010 for the adoption of the International Public Sectors entities in Nigeria. After this, the Office of the Accountant General of the Federation through a sub-committee of the Federation Account Allocation Committee (FAAC) established in June 2011 developed the new BC & CoA, which the Federal Government and almost all States in the Federation (including Bayelsa State) have now migrated to. This makes it imperative for all the eight (8) Local Governments (LGs) in the State to follow the same path and adopt the new BC & CoA as they affect public expenditure and financial management operations in the Local Government Councils.

Indeed, the subsequent National Treasury Circular of May 2013 among others, enjoined both States and Local Governments to implement IPSAS Complaint Budget and Accounting formats. Based on the above, the 8 Local Governments of Bayelsa State are committed to the implementation of the IPSAS Complaint Budget and financial reporting with effect from the 2023 fiscal year. This manual is therefore prepared to guide the users to use the BC & CoA for effective implementation.

## 1.1 - Benefits of IPSAS Compliant Budget Classification (BC) and New Chart of Accounts (NCoA)

The benefits and advantages of adopting the IPSAS Chart of Account include the following;

- 1. Improve accountability and transparency hence, quality service delivery
- 2. Ensure credibility/integrity that will build confidence in partners and other stakeholders
- 3. Secure political and economic leverage
- 4. Ensure comparability in line with international best practices.
- 5. Greater disclosures provide information for better decision-making and in turn, lead to better use of public resources.
- 6. To enhance the Fiscal Operation Report that will increase control of public agencies.
- 7. Enhance Public Private Partnership arrangements.
- 8. Increased cross-border investment and foreign direct investment.
- 9. Enhance the adaptation of the Freedom of Information (FOI) Act, 2011

### 2.0 - Structure of the Revised Chart of Accounts

The Chart of Accounts is made up of six (6) segments of 26 parts and 52 digits each representing an essential detail of each transaction. The six segments and their parts are shown in Table 1. In designing the CoA, an effort has been made to comply, as much as practicable, with the IMF Government Finance Manual 2001 (GFS), International Public Sector Accounting Standards (IPSAS) of International Federation of Accountants (IFAC) reporting requirements and other known modern public sector budgeting and accounting coding models. The Economic Segment of the COA has been modelled using the **REAL** (*Revenue*, *Expenditure*, *Assets and Liabilities*). This will enable easy migration to IPSAS accrual basis of accounting in future. Table 1 below presents the picture of each segment of the COA.

### 2.1 - Administrative Segment

Administrative classification provides information on the public sector organisations that incur expenditures or receive revenues on behalf of the government. An administrative classification of expenditure is needed to identify responsibilities for the main blocks of public expenditure and the day-to-day administration of the budget. The administrative classification identifies the entity that is responsible for managing the public funds concerned – such as Treasury, Works, Agric, Community and Water Sanitation and Hygiene Departments or at the lower level, Building, Livestock and Water sections of the Local Government.

The Administrative segment is made up of twelve (12) digits and is broken down into 5 levels. The levels, components, number of digits and descriptions are presented in Table 2 below.

For practical application, levels 3 and 4 have effectively been merged to form a six-digit code (combining sub-org and sub-sub-org). The sub-sub-sub organisation (level 5) is not currently being deployed.

### 2.2 - Economic Segment

The Economic segment answers the "What" question of every transaction whether receipts (revenues) or payments (expenditure). Economic classification identifies the type of revenue received (whether recurrent revenue such as Internally Generated Revenue and Federally collected Revenue or Capital receipts such as Aid & Grants, Loans, etc.) or expenditure incurred (whether recurrent expenditure — personnel cost (salaries and allowances) and Other Recurrent also referred to as overhead costs (transport & travelling, office materials, maintenance of vehicles, etc) and Capital expenditure. Economic Segment has 8 digits and is made up of five (5) different grouping levels as shown in the Table 4 below.

### 2.3 - Function Segment

The functional classification categorises expenditures according to the purposes and objectives for which they are intended. Functional Classification or Classification by Functions of Government (COFOG) is defined as a detailed classification of the functions, or socioeconomic objectives, that general government units aim to achieve through various kinds of outlays. It comprises 5-digit codes. A "functional" classification organises government activities according to their broad objectives or purposes (for example, education, social security, housing, etc.). It is independent of the government's administrative or organisational structure. A functional classification is especially useful in analysing the allocation of resources among sectors. It may also be used for tracking poverty-reducing expenditures. COFOG is divided into three levels as presented in *Table 9* below.

## 2.4 - Fund Segment

The Sources of Funds refer to the various means of funding government activities. Payments in respect of Salaries and Overhead Costs for instance may be funded from the Local Government's regular budget/main envelop or capital expenditure may be funded from Aid and Grants from local or foreign bodies. Other possible sources of funds are Capital Development Fund, Consolidated Revenue Fund (Charges), etc. The Source of Funds code is used to uniquely identify the means of funding each transaction. The structure of the Fund segment is presented in *Table 11* below.
